#### **Committee Reports:**

- a) ACB Report- 2 solar panels, 1 deck and 1 fence were approved.
- b) Maintenance Report-Did put up shade cover over the playground at Black Creek Park. Rich did purchase a new cell phone which would provide him a service when contacting office staff or when documenting incident reports. Rich has a new maintenance helper who is relieving Rich enough to allow for him to accomplish much more.
- c) Events Committee Report- Dianna Lopez Event Committee chair- had the Annual Flea Market. She is working on her financial report. Fourth of July is being held July 7<sup>th</sup>. Carne Asada is the main dish to be served. Snow cone machines, water slides and a lot of fun activities for all CCLTOA members and their families. Always seeking volunteers on the committee.
- d) Kiva Committee Report- Renee Irwin committee member- The bulletin board is up at the Kiva. Ray is working on installing a shower for members to rinse off before getting into their cars. The shower will be installed on the left side of the women's bathroom. There are some concerns as to the location set up which might conflict with pedestrians.

#### Old Business:

a) Overnight Dock Rental for Weekends- Previously proposed from Kiva Committee which was then tabled. For a fee of \$30.00 association members could secure a boat slip. #### **New Business:**

a) Move \$28,080 from Reserve to Operating Account-When paid the contractor for boat ramp resurfacing Funds came from the operating account so the money needs to be moved from the reserves to operating.

- b) Annual Meeting Lunch 8/18/12- LeRoy would like to bring back the luncheon portion of the Annual Membership meeting as CCLTOA has done in the past. Stacy has been budgeting money from Board meeting funds very well with the help from Dianna Lopez saving and freezing cookies. The line item will have funds left by end of year, so \$500.00 can be spent for luncheon on 8/18/12 for the annual meeting. Motion to approve. Approved 5-0.
- c) No Smoking Sign for Kiva-Member's have been complaining about smoking at Kiva. Smoking area will be imposed at Kiva. No need to make a motion to approve.

#### Meet the Candidates Forum-Question & Answers:

Renee introduced this portion of the meeting to the members present. The candidates were introduced in alphabetical order.

- a) LeRoy Lopez- was appointed last September when a past member resigned. LeRoy was able to be point person for office staff. He has been able to lower cost with propane. He also helped to decrease expense by purchasing a new copy machine. In 1 year the copier will pay for itself and will save the Association \$9,000.00 per year thereafter. He also helped in resurfacing the Kiva boat ramp with 1" concrete grooved cement. Also he has gotten both male and female bathrooms remodeled to provide wheel chair access. LeRoy was a very proactive member in the investigation in order to recoup lost funds. LeRoy wants to get more shade at Kiva and extend the launch ramp. Rob feels he is a valued asset to the board and would like to see him continue on the board.
- b) Art Roberts- His interest is for the members and would like to help improve it. In the past few years it has been in bad shape. Monies have come and gone. The Association has gone through numerous attorneys and doesn't know why. He feels unprivileged to that information. The Association's new attorney is Deon Stein. Member Doug Rocky had a question but Art will not answer his question. Rob has only served for 6-8 months and feels the day to day minutia is from a small group of people and doesn't know why. He might not agree with everyone but he tries to help who he can, like how he tried to help the Radcliff's and Gutmans.
- c) Patrick Storey- has lived here since 1990 and has raised 3 sons here but things have changed. Privileges have been lost and he would like to be on the board to help keep the Association positive and the way it was when he moved here and had more privileges. What is eroding the Association are some homeowners that have petitioned to disband the Association and bankrupt it. He has been married for 31 years. Art Roberts asked him if he was aware of the Tuscany Hills Project program in which the county wants to redevelop this area. He asked Patrick Storey how he felt about that. The answer was absolutely he does not care for it. Question: Are you aware the county is raising taxes from \$130.00 to \$170.00 to do landfill. How would you handle that? Answer: Keep HOA dues down and tax monies out of county official's pocket.
