New Business:

- a) Correction to the 2/21/2013 Board Meeting Minutes- Office Manager Donna explained that the minutes claims that Ralph Copeland's position was that the short term rental control should be CCLTOA-HOA's responsibility but it is incorrect. The Copeland's' feel that in regards to short term rental it should be the responsibility of the County.
- b) Lot 1013 Application for Variance: storage/hobby shop- the shop would be out of sight, metal bldg, size is 24' X 42' with a 14' wall. Neighbors had no objections and cypress trees would be planted to surround shed so will not be visible from the road. The variance is for the size, motion made to approve. Approved 3-0.
