- b) Maintenance Report- Corey- Completed striping at Black Creek and Kiva, fixed toilet, replaced fascia boards at the Kiva. Ordered valve for the Kiva shower head, fixed the sprinkler system, disposed of a dock that floated in, and getting shade for the ball park. Installed cameras and wiring inside gym and Black Creek. Five gallon electric water heater leaking, researching repairs or replacement. Shade up on the playground.
